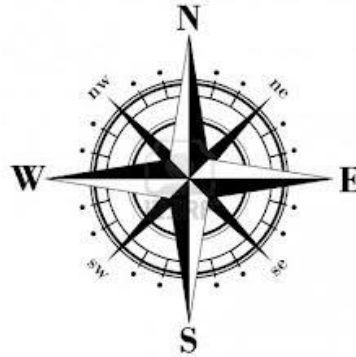

What do I do next? A good place to start....



At this point you have identified that there is a problem with your financial records. You've realized that you are a victim of *unauthorized* charges. You've noticed something wrong on a statement, or you have been called by your Credit Card Company, Bank or Financial Institution or somehow identified that some piece of your Identification has been used without your permission. You've made a police report with The Johnson County Sheriff's Office.

NOW WHAT DO YOU DO?

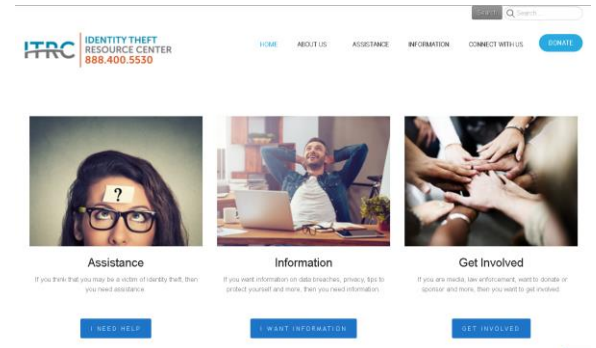
We suggest you get a notebook and start a detailed log of your contacts and activities. Keep paper and digital copies of statements, reports and other documents for future reference.

(Hint: take pictures of documents as you update them with your phone if you don't have a scanner available.)

In order to Flag your credit reports, enact a 90 day fraud alert, a 7 year fraud alert, and/or Credit Freezes to the three credit bureaus:

❖ **Contact the IRS**
